Amendment to Animal Control Ordinance to Include Spay and Neuter Requirement







The Baldwin County Board of Commissioners has proposed an amendment to the animal control ordinance in order curb the size of the unwanted pet population in the community. This spay and neuter requirement will help to reduce the unwanted breeding of animals. The amendment states that no person may own, keep, harbor, or have custody of a dog or cat six months of age or older within Baldwin County that has not been spayed or neutered unless such person holds an unaltered animal permit for each unaltered dog or cat, or unless the dog or cat is otherwise exempt.

Over the past several years, Baldwin County has increased the capacity of animal control and the animal shelter but have yet to get a handle on the large intake numbers at the shelter. It is not uncommon to have more than 100 animals in the shelter despite utilizing the Animal Rescue Foundation and other animal rescues all over the country to place these animals. Additionally, the shelter offers adoption services and has utilized coordinators in both areas to find the animals in their care a home and avoid mass euthanasia. Unfortunately, far too many animals are euthanized due to lack of finding placements for these animals.

The shelter budget this year is \$449,000, more than double the 2018 budget due to the demands to provide shelter and food for the unwanted pet population. Until the county gets a handle on this issue, the taxpayers will be funding a losing battle as the number of stray pets in the community continues to grow further out of control. A public hearing is scheduled for Tuesday, April 15th at 5:00 p.m. at the Baldwin County Adminstrative Building.

New Additions Planned for Coopers Park






Coopers Park is planned to receive two valuable additions - a rain garden and splash pad. The Baldwin County Board of Commissioners, Coopers Collaborative and Georgia College and State University plan to build a rain garden in Coopers Park on Saturday, April 5th. The rain garden's primary purpose will be to contain stormwater runoff and soil erosion from reaching the park's walking path.

Baldwin County will be opening splash pad proposals on Wednesday, April 9th at 2 pm. The county aims to build a splash pad at Coopers Park nearly identical to the one at Harrisburg Park (pictured above right). The rain garden and splash pad are two of the improvements identified in the "Coopers Park Reimagined" plan.

The Fishing Creek Trail Extension-Downtown Connector Bids to Open Soon


The Fishing Creek Trail Extension-Downtown Connector will be advertised for construction the week of April 6th. Bids will be due May 6th and commissioners are scheduled to award a contract on May 20th.

The 0.57 mile paving of this final section of unpaved trail will provide safe and continuous trail connectivity between the Oconee River, Georgia Military College, and Georgia College and State



University, enhancing the ease of travel and recreational opportunities for students and others. All horizontal and vertical clearing has happened already. The site is graded and no other land disturbance activities are anticipated other than preparing the ground for the 0.57 mile-long and 10-foot-wide concrete path. The project will include installing a 40 foot storm drain pipe and two drop inlets.


The Harrisburg Park New Community Center Bids to Open April 11th




The Harrisburg Park New Community Center bids are due Friday, April 11th at noon.

Kinetic Fiber Internet Now Available to **Unserved Areas in Baldwin County**

Baldwin County and Windstream Windstream Partnership recently completed a \$1.9 million broadband project that was funded by the American Rescue Plan Act State Fiscal Recovery Fund. This project funded broadband deployment to over 600 residential homes.

that are underserved or unserved, have access to high-speed internet. The project will help to meet four major goals that the Baldwin County Board of Commissioners have for its community:
