EXECUTIVE SUMMARY

Baldwin County closed the landfill at 170 Union Hill Church Rd. The property has 533.84 acres. The county recently fenced and locked Phase 3 of the landfill. Phase 2 of the landfill is not available for hunting either. Please see attached map. Baldwin County now seeks bids from individuals or firms for a hunting lease of the remaining 439 usable acres of the landfill.

SPECIFICATIONS

The successful bidder will have 24/7 access to the property during the one-year lease. The successful bidder will have access to all paved, rocked and dirt roads on the property. There is a trailer and one building inaccessible to the successful bidder. The county will provide an option to lease the property for nine individual one-year extensions. Extension has to be acceptable to county based on their cooperation and good stewards of property. Baldwin County requires a price per acre for each one-year term. All bidders must complete the bid form and submit it by the due date as described in "Instructions to Bidders."

Baldwin County staff and contractors will have access to the old landfill to mow the grass and perform tasks for state-mandated closure reports. All tasks shall occur Monday through Friday between 7:30 AM and 5 PM. These tasks are performed irregularly and the successful bidder shall be notified in advance when these tasks will occur.

INSTRUCTIONS TO BIDDERS

Bidders shall provide a dollar amount per usable acre for a one-year period plus option years. Bids are due electronically or by mail on Monday, August 25, 2020 by 12 PM. Bids shall be submitted to ctobar@baldwincountyga.com. They may be mailed to:

Baldwin County will accept the highest bid if it is acceptable to the County. If it is not acceptable to the County, all bids will be rejected. Upon execution of hunting lease and provision of the certificate of insurance the successful bidder may take possession of the property.
